## 2019 VOLUNTARY FAMILY CONTRIBUTION PRESCHOOL TO YEAR 6

Dear Families,

Each year Ainslie School invites families to make a voluntary contribution. The money raised is an important way that our community can enhance the education of the school.

Parents and carers are able to distribute their contribution across three areas, two of which are tax deductible. They are:

1. **Ainslie School Fund** These funds are used for resources across a range of areas, including art supplies, musical instruments, sports equipment and maths and science resources
2. **Ainslie School Goodwin Library Fund (tax deductible)** These funds are used to purchase books, literacy resources and technology devices that are part of the library collection.
3. **Ainslie School Building Fund (tax deductible)** These funds are used to pay for building projects.

**The annual voluntary family contribution set by the Ainslie School Board is \$90 for one student and \$115 for a family of two or more children attending the school.**

Any contribution is welcome and if you wish to pay by instalments we are pleased to facilitate this for you. Some families choose to provide a higher amount, some less and of course there are many other ways that families can contribute to the school. Volunteers are always welcome and we encourage you to participate in the various activities that are organised throughout the year. Please be assured that your child will not be refused benefits or services if you choose not to make a financial contribution. Individual records of contributions are confidential as specified in the Education Act 2004.
